 - o Just a reminder that we have a process in place specifically to keep certain people informed about what is happening with marketing, communications, and web presence. These people need to be aware of what is happening on the front end of this process. Specifically so we are not caught unawares when things might not happen on time. You may have people working those projects for you, which is fine, but we still need to be aware so that we can guide the process, make suggestions, step in when necessary to help or correct, or to keep things on track so printing is happening 5 weeks before the event. It is about managing resources, and expectations.
 - Thus far only Robert and Myself are the only ones who have actually filled out the
 provided form. Outside of that, I've had to interview people to get all of the information
 and that is what the form is supposed to alleviate, no one has time for that. If you can't
 find the form please reach out, I'm happy to send it to you directly.
 - ∘ I know there are events coming up, but... I officially don't know anything about them except for Bowling... because nothing has been submitted to me.

Schedule:

• At this moment in time Bowling is the only thing on my radar. First, I'm working off of the Bylaws that are posted to the website. I don't have access to the live document. I have a few things that we need to look at before the Election....

- Motion 1: WE need to update the Bylaws in regard to Voting, there is wording that prevents us from using Google forms to our advantage.
 - Section 2, Subsection M, Subsection 4,
 - o 4. Proxy voting and absentee voting shall not be allowed.
 - Strike "Absentee" from the sentence
 - This will allow our secretary to utilize modern technology "Google Forms" and provide the fair election for all of our players which I hope this organization should be striving for.
 - This isn't the president of the United States, and there are ways we can make sure that the vote is coming from the correct people.
- Motion 2: Section 2, Subsection M, Subsection 5
 - All appointed Board Member terms will end after the next election. The "elected" board shall fill the appropriate positions after they are elected in October.
 - This leads me to believe that when EACH year's election comes around ALL but 5 positions are evacuated until appointments are made. This will be a hindrance in the long run
 - I was under the impression that even though our positions are appointed, they are two year terms and are subject to the same removal processes and the original 5 positions.
 - This needs to be clarified before this election comes to pass, or we are all out of a job if it's not fixed.
